

# CONDITIONS - PICE / MOBILITY CALL - MARCH 2019 SCENIC ARTS - VISUAL ARTS - FILM & DOCUMENTARY - LITERATURE & BOOKS - MUSIC

### 1. Purpose of the grants

- 1.1. The main purpose of the Programme for the Internationalisation of Spanish Culture (PICE) of the state agency Acción Cultural Española (AC/E), in the Mobility category, is to boost the capacity of Spain's culture sector and its creative industries to operate internationally, by promoting the international circulation and mobility of works, productions, artists, creators, agents and culture and creative professionals from Spain at the request of international cultural organisations and institutions.
- 1.2. The Programme is designed to encourage foreign organisations and institutions of interest in the cultural field both public and private to feature Spanish or Spanish-resident artists, culture professionals and cultural creators in overseas programmes in order to enhance the international visibility, mobility and recognition of the latter, who should preferably be artists, professionals and creators at an intermediate stage in their careers and in need of international exposure.
- 1.3. With its grants, the Programme stimulates the internationalisation of Spain's creative and culture sector by fostering its transnational circulation through the presence of Spanish creators and professionals in overseas activities generated and promoted by these foreign culture organisations and institutions which feature them in international events, festivals, exhibitions, tours, etc.
- 1.4. Projects relating to the attendance of seminars, conferences, meetings and specifically academic events held abroad are excluded from the scope of the Programme.
- 1.5. To publicise this programme of grants, Acción Cultural Española may enlist the collaboration of the specialised cultural agencies of the office of the Ministry of Culture and Sports, Cervantes Institute, the Spanish Agency for International Development Cooperation and their respective overseas networks, as well as Embassies of Spain throughout the world.

## 2. Submission of applications and closing date

- 2.1. Grants can be applied for exclusively by foreign cultural organisations and institutions from 00:00 (GMT + 1) on the **1<sup>st</sup> March** of the current year to 24:00 (GMT+1) on the **31<sup>st</sup> March** of the same year.
- 2.2 Grants can only be applied by entities legal and tax incorporated in its country of residence and with the capacity to issue commercial invoices.
- 2.3. Only applications properly completed (online) in Spanish or English in the computer



application accessible from the restricted area of AC/E's website will be accepted.

- 2.4. Incomplete applications will not be accepted, and any that fail to comply with the requirements laid down in the conditions of this call will be rejected.
- 2.5. The electronic application form in the computer application can be accessed (online) through <a href="Mailto:AC/E's website">AC/E's website</a> or by clicking on the following link: <a href="https://goo.gl/DtbmPo">https://goo.gl/DtbmPo</a> during the period referred to in point 2.1.

To access PICE computer application, applicants must identify themselves as registered users (by entering user login and password).

## 3. Application requirements

- 3.1. Candidate Spanish cultural artists, professionals and creators for the PICE/Mobility grants can only be proposed by foreign cultural organisations and institutions belonging to the field of performing or visual arts, film and documentary, literature and/or music. Proposals will not be accepted from any other type of institutions or from individuals.
- 3.2. The proposed activity projects must include a commitment from the applicant to fund at least 50% of the activity for which the grant is requested.
- 3.3. Applicants must expressly confirm this commitment to co-fund the project for their applications to be considered.

#### 4. Assessment of applications and award of grants

- 4.1. Grants will be awarded by AC/E following a competitive procedure whereby the activities and candidates proposed in the applications will be assessed by the external committee of prestigious independent advisors designated by AC/E for each area in accordance with the quality and interest of the proposed activity programme.
- 4.2. In accordance with AC/E's #FocoCulturaEspaña: Mexico priority will be given to projects submitted by cultural organizations belonging to that country
- 4.3. The following factors will be considered with respect to the PROFILE OF THE APPLICANT ORGANISATION OR INSTITUTION:
  - it is a foreign organisation or institution, public or private, that is culturally significant in its country of origin or internationally reputed;
  - the foreign organisation or institution has sufficient means and capabilities to carry out
    the proposed activities for which the grants are requested and to guarantee compliance
    with the conditions that regulate them.
- 4.4. The following factors will be considered with respect to the PROFILE OF THE ACTIVITY PROJECT:
  - the activity is part of a general project that is feasible and has continuity;
  - it is preferably an activity originating from an activity project previously approved under the Visitors category of the PICE;
  - the project will be carried out in a country of special interest or priority action according to the AC/E guidelines and a benchmark in the culture sector to which it belongs.
  - · the project helps consolidate the presence of the Spanish professional or creator on



the international scene:

- the project includes sustainability criteria in its definition or execution
- 4.5. The following factors will be considered in relation to the CANDIDATE/SPANISH PARTICIPANT PROFILE:
  - He/she should preferably be artists, professionals and creators at an intermediate stage in their careers and in need of international exposure.
  - He/she should submit a quality proposal
- 4.6. As mentioned in point 1.4., projects relating to the attendance of seminars, conferences, meetings and specifically academic events held abroad are excluded from the scope of the Programme.
- 4.7. Proposals from any other type of institutions different than mentioned in point 3.1. or from individuals will not be accepted.
- 4.8. The decision period for the award of the grants will be twenty-three (23) calendar days from the closing date for the submission of applications.
- 4.9. AC/E will not be under obligation to award the same amount the applicant has required. The awarded grant could be higher or lower than the requested amount, but it will never exceed fifteen thousand Euros (15.000€).
- 4.10. The provisional list of foreign beneficiary organisations or institutions will be published on <u>AC/E's website</u> after the end of the decision period.

The list must be consulted by the applicants; therefore AC/E is not under obligation to individually communicate the results to the beneficiaries.

- 4.11. The abovementioned beneficiaries must confirm their acceptance, through the computer application, within **five** (5) calendar days from the 24<sup>th</sup> to the 28<sup>th</sup> of April 2019. By accepting the grant, beneficiaries undertake to agree to the present conditions and comply with the obligations derived therefore.
- 4.12. A beneficiary will be understood to desist from their grant request if notification of acceptance is not received within the abovementioned period, after which the final and definitive list of beneficiaries will be published on AC/E's website on the **30**<sup>th</sup> of April **2019**.
- 4.13. After the deadline for acceptance of the grants has expired, AC/E may assign non-accepted grants to alternate and/or already awarded beneficiaries.

### 5. Obligations of beneficiaries

5.1. Grant beneficiaries undertake to agree to these conditions and comply with the obligations



derived therefore, after accepting the grant as described in point 4.11 and 4.12.

- 5.2. AC/E will not assume any medical expense generated during the stay of Spanish participants in the project host country. The beneficiary entity must have a medical insurance that will cover these eventualities.
- 5.3. The activities proposed by the beneficiary applicant organisations must be performed according to the following calendar:
  - Scenic Arts, Visual Arts, Literature and Music: within a maximum period of six (6)
     months between the 1<sup>st</sup> of July and the 31<sup>st</sup> of December of 2019
  - Film and Documentary: within a maximum period of five (5) months between the 1<sup>st</sup> of May and the 30<sup>th</sup> of September of 2019
- 5.4. After accepting the grant, the beneficiary must notify the Spanish artists, professionals or creators taking part in the activity project, directly and individually with a copy to AC/E (see point 2.7), by means of the following text: 'Your participation in this project has been made possible by the Programme of the state agency Acción Cultural Española (AC/E) for the Internationalisation of Spanish Culture (PICE), in the Mobility category, which facilitates the presence and collaboration of Spanish or Spanish-resident artists, professionals or creators in the international activities and programmes of foreign cultural organisations and institutions, both public and private'.
- 5.5. If, after the beneficiary has accepted the grant, any changes are made to the terms of the project previously approved by AC/E (place, dates, participants, etc.) for duly justified reasons, AC/E must be notified of these changes as soon as possible so that it can confirm its decision to maintain the award of the grant in view of the proposed changes. AC/E undertakes to notify the beneficiary in writing, as soon as possible, of its acceptance of the changes.
- 5.6. AC/E will not accept any changes in the participant list once the event has started. AC/E will neither accept any expenses from non-approved participants before the commencement of the event.
- 5.7. The beneficiary undertakes to collect in writing from each of the Spanish artists, professionals or cultural creators participating in the project object of the grant approved by AC/E, as holders of their personal data, the informed consent that when assigning them they authorize their use by AC/E for the purposes of managing this Program, as well as to coordinate directly with them actions to disseminate the project (such as the use of the corresponding image, graphic, textual resources, etc., in its different supports) and exchange of resources (interviews, workshops, professional meetings, etc.), and for the creation of future work networks and collaborations.

Likewise, the beneficiary undertakes to obtain the informed consent of the candidates approved for

the use of the data provided in the application in order to maintain the web and social networks of AC/E. In case the applicant has not completed the information required by the system, or he/she

hasn't done it properly, AC/E may use the one that it considers most appropriate. Both the

beneficiary and the candidate can contact AC/E to update and/or modify any of the information

5.8. Acceptance of the grant entails the beneficiary's willingness to collaborate by responding to a

survey on the quality of the PICE/Mobility that AC/E conducts regularly in order to improve the

functioning of the Programme.

5.9. The Spanish participants in the foreign activities, programmes, events, festivals, etc. for

which AC/E grants are awarded will be invited to take part in the Programme's network of

participants, which they will be able to register with and access.

5.10. Once the grant is awarded, the beneficiary must contact AC/E's Press Service\* to

coordinate any information on the beneficiary activity that is being prepared to be sent to the

media (press releases, dossiers...). This information must include an explicit reference, agreed

with the Press Service, to the support the activity is receiving from the Programme for the

Internationalisation of Spanish Culture (PICE) of Acción Cultural Española (AC/E) in the Mobility

category.

5.11. With sufficient anticipation and at least fifteen (15) days before the start of the activity for

which the grant is awarded, the beneficiary must contact AC/E's Digital Dissemination, Web and

Social Media Service\*\* about displaying the collaboration of Acción Cultural Española (AC/E) in

all graphic and dissemination materials and digital documentation related to the project for which

the grant is awarded, using the logos provided for this purpose.

6. Payment of the grants

6.1. The mobility grants will be paid by AC/E once the project is completed. Only under very

exceptional circumstances and in duly justified situations motivated by reasons beyond the

organization of the project, applicants may request payment in advance of part of the grant

provided this is justified and upon request and written authorisation from AC/E.

Under such exceptional circumstances, payment in advance approved by AC/E and duly justified,

two payments will be established: one upon submission of an invoice for said 50%, and a second

following completion of the activity. In both cases invoices must be submitted as established in

point 6. Payment of the grants.

This request of payment in advance can be proposed to any area except for Film and

Documentary.

6.2. Once the activity has been performed, in order for the grants to be paid, beneficiaries must

submit by e-mail, with annexed scans, to the emails detailed in point 2.7, proof of completion of

the activity and of how the funds have been used. Namely:

1. Invoice for the amount of the grant or of the justified expenses, which must include the

Invoices must include the intracommunity VAT number of the

issuing organisation or justification that it is not under obligation to

have one, as well as its name or business name and address.

Invoices must contain the issuer's full bank details, IBAN number

and Swift code.

Organisations resident outside the European Union for tax purposes:

invoices must include full details of the issuer (name or business



name, address and tax ID code if applicable). Invoices must contain the issuer's bank details: Swift code, account number, name of the account holder and of the bank, and it must be ensured that the bank accepts transfers in Euros.

 A Financial report specifying the expenses covered by the grant. These expenses must be directly related to the activity for which the grant is awarded, not general expenses of the beneficiary institution.

It must contain a classified list of expenses and date of payment specifying the supplier, the concept as well as the total amount of each of the expenses.

- 3. Copy of invoices accounting for the total amount of the grant
  - Invoices issued in local currency, in proper and due form, or documents providing valid proof of each of the expenses listed in the financial report.
  - To calculate the Exchange rate, use the information published by the Bank of Spain for quoted currencies. Ir al Banco de España.
  - If the beneficiary institution has allocated an amount for per diem expenses, these shall only be justifiable by a document signed by the Spanish participant by which he/she confirms the abovementioned institution has assumed these expenses. The daily amount shall not exceed the limit determined by **Royal Decree 462/2002**, 24th May, regarding reimbursement of expenses published on B.O.E. (Spanish Official Gazette 30/05/2002) (see Royal Decree) for GRUPO 2 and for the country where the project has taken place.

If the beneficiary institution has arranged the meals by catering services arranged in restaurants, the subsistence expenses shall be justifiable by the presentation of the invoices issued for these services, as long as the daily amount per person does not exceed the limit determined for GRUPO 2 by Royal Decree 462/2002, 24th May, regarding reimbursement of expenses published on B.O.E. (Spanish Official Gazette 30/05/2002).

Under no circumstances shall the subsistence expenses be justifiable by tickets of purchases of food and beverage in different business or purchases of food in supermarkets, among others.

- o Regarding travelling expenses, economy class tickets will be preferred
- o For overnight stays, three or four-star hotels will be preferably chosen
- o Expenses generated by participants who have not been present at the



beneficiary project **won't be accepted**. AC/E will neither accept expenses from participants who haven't been approved by AC/E before the commencement of the event.

- Expenses derived from participants' fees won't be covered by AC/E.
- Expenses derived from purchases of necessary materials for the project will be only accepted as production expenses. Reusable goods won't be covered by the grant.

## 2. An Activity Report including:

- Technical specifications of the project
- o Programme of the activity carried out
- List of participants and guests and number of visitors
- A dossier on its impact on the media and social networks as well as the press, including a copy of all information on the project appearing in them and/or in other materials
- o Brief report of conclusions on the activity and its public impact
- 3. Three high resolution digital photographs of the activity and the Spanish participants
- 6.3. Following completion of the project, only when the beneficiary has submitted the abovementioned documentation and the latter has been examined and approved by AC/E's Department of Programmes and Financial Department will AC/E pay the sum awarded to the beneficiary, by bank transfer in a single payment within a maximum period of thirty (30) calendar days from the abovementioned examination and approval, upon submission of the related invoices.
- 6.4. Payment will be made **only to the beneficiary entity** and only in bank accounts located in financial entities based in the beneficiary's country.

Payments in financial entities based in a different country from the beneficiary's, won't be accepted.

6.5. If the beneficiary has failed to submit the above documentation within a ten (10) week period (seventy (70) calendar days) from completion of the activity for which the grant is awarded, they will be understood to renounce the grant awarded. This period will be **non-renewable**.

If there is a justified delay or change in the date of termination of the mentioned activity, the beneficiary must inform AC/E immediately to accordingly adjust the referred maximum period.
